Important Note to C.O.P.S. Member:

There will be a \$250 charge for WILLS for spouses that are NOT added to your Legal P.L.U.S. plan with no exceptions. Upon completion of the first draft it will be emailed to you for your initial review. Once critiqued to your approval, you must execute your Will before two (2) witnesses that have no invested interest in your estate and before a Certified Notary Public. After execution, you can file your original WILL with the County Clerk's Office. The "Original" must be presented at the time the Will is Probated.
